The district's activity committee will look at his decision and then it will need board approval. Mr. Brackbill said a trip to Virginia looked promising. The trip is usually scheduled during Christmas break.

**President's Report:**

Mike shared that the Boosters are moving towards technology. This is leading to the development of a website, [www.mcmarchingbaron.org](http://www.mcmarchingbaron.org). It is believed that a permission for pictures form will be needed to allow students to be on this website.

The executive members are also looking to support music program as whole. This would include the middle school and elementary schools.

Mike reminded that there is 1 year until elections. At least 3 executive members will need replaced.

The updated by-laws were read. The by-laws were approved unanimously.

Mike informed the booster that the executive committee had already approved drill and music costs.

Mike shared that there will be a need of 3 point-people to assist coordinate the trip. They will serve as committee to assist with decision making and direction for the trip. These volunteers will need background checks.

Reimbursement forms will be used from now on to assist with keeping track of cost for purchases. It can also be used as a donation form. This will be used for staff and volunteer purchasing.

The executive committee was approach by a former family to discuss replacement of instruments. The donor is willing to match up to \$25,000. Mike asked for assistance from the boosters to find donors to match this. Donations are tax deductible. A suggestion was made to have seniors challenged to come up with a fundraiser.

**New Business:**

It was suggested that rookie parents need more help, especially "super-freshie" parents, in understanding the many aspects of being a marching band parent. A suggestion was made to have another meeting in September to assist with this or a rookie meet and greet. This area will need further exploration.
